The Golden Sentry End-Use Monitoring (EUM) program is designed to verify defense articles or services transferred by the United States Government (USG) to foreign recipients are being used in accordance with the terms and conditions of the transfer agreement or other applicable agreement.

Blue Lantern's mission is to help ensure the security and integrity of U.S. defense trade. The EUM program is designed to minimize the risk of diversion and unauthorized use of U.S. defense articles, combat gray arms trafficking, uncover violations of the AECA, and build confidence and cooperation among defense trade partners.
