## WEEKLY TIPS ROUND UP

- Do you know your provisos? The approval process is only half the battle. Approved ITAR and EAR licenses will have limitations/stipulations attached to the authorization that you will need to meet to export your goods, service, or technology.
- Not everyone speaks "exports" like you do! Hold a "KICK-OFF BRIEF" upon export authorization approval to make sure everyone operating under the authorization knows the "do's" and "don'ts."
- Did you know that your ITAR Agreement can include end-users who are not foreign licensees? We call them "non-signatory end-users" and they are useful in situations when an end-user receives defense articles but does not require technical data or defense services beyond basic operation and maintenance.

# MAJOR ARMS SALES

#### **ISRAEL**

**READ** 

The Government of Israel has requested to buy up to eighteen (18) CH-53K Heavy Lift Helicopters; up to sixty (60) T408-GE-400 Engines (54 installed, 6 spares); and up to thirty-six (36) Embedded Global Positioning System/Inertial Navigation Systems (EGI). The proposed sale will improve the Israeli Air Force's capability to transport armored vehicles, personnel, and equipment to support distributed operations. Israel will use the enhanced capability as a deterrent to regional threats and to strengthen its homeland defense. The total estimated cost is \$3.4 billion.

#### THAILAND

READ

The Government of Thailand has requested to buy three hundred (300) Javelin FGM-148 Missiles; and fifty (50) Javelin Command Launch Units (CLU). This proposed sale will contribute to the foreign policy and national security objectives of the United States by improving the security of a Major Non-NATO Ally in Southeast Asia. The total estimated cost is \$83.5 million.

#### **INDIA**

**READ** 

The Government of India has requested to buy one (1) Harpoon Joint Common Test Set (JCTS). This proposed sale will support the foreign policy and national security of the United States by helping to strengthen the U.S.-Indian strategic relationship and to improve the security of a major defensive partner, which continues to be an important force for political stability, peace, and economic progress in the Indo-Pacific and South Asia region. The estimated total cost is \$82 million.

#### **GEORGIA**

READ

The Government of Georgia has requested to buy eighty-two (82) Javelin FGM-148 Missiles; and forty-six (46) Javelin Command Launch Units (CLU). The Javelin system will help Georgia build its long-term defense capacity to defend its sovereignty and territorial integrity in order to meet its national defense requirements. The estimated total cost is \$30 million.

#### **GREECE**

**READ** 

The Government of Greece has requested to buy U.S. Government and contractor engineering, technical, and logistics support services of F-16 Sustainment Materiel and Services and related equipment for an estimated cost of \$270 million. The proposed sale will improve Greece's capability to meet current and future threats by providing agile logistics support to its F-16 program, encompassing aspects of aircrew training and aircraft maintenance.

#### JAPAN

**READ** 

The Government of Japan has requested to buy up to forty-four (44) Rolling Airframe Missiles (RAM) Block 2 Tactical Missiles, RIM-116C. The proposed will provide significantly enhanced area defense capabilities over critical East Asian and Western Pacific air and sea-lines of communication. Japan will have no difficulty absorbing these services and support into its armed forces. The total estimated program cost is \$61.5 million.

## MAJOR ARMS SALES NOTIFICATION

**JAPAN** 

READ

The Government of Japan has requested to buy Follow-On Technical Support (FOTS) of AEGIS Class Destroyers. The proposed sale is critical to ensure Japan Maritime Self Defense Force's (JMSDF) Aegis Destroyer fleet and the Japanese Computer Program Test Sites (JCPTS) remain ready to provide capabilities in the defense of Japan. The total estimated program cost is \$134 million.

**TECRO** 

**READ** 

The Taipei Economic and Cultural Representative Office in the United States (TECRO) has requested to buy forty (40) 155mm M109A6 Medium Self-Propelled Howitzer Systems; twenty (20) M992A2 Field Artillery Ammunition Support Vehicles (FAASV); one (1) Advanced Field Artillery Tactical Data System (AFATDS); five (5) M88A2 Hercules vehicles; five (5) M2 Chrysler Mount .50 caliber machine guns; and one thousand six hundred ninety-eight (1,698) multi-option, Precision Guidance Kits (PGK). This proposed sale of M109A6 SPH will contribute to the modernization of the recipient's self-propelled howitzer fleet, enhancing its ability to meet current and future threats. The total estimated program cost is \$750 million.

## REGULATORY POLICY UPDATES

ALLEGED VIOLATIONS ARE JUST AS COSTLY...

The Department of State concluded a \$6.6 million settlement with Keysight Technologies Inc. for alleged export violations of unauthorized software (technical data) used for testing radar equipment on fixed or mobile platforms.

U.S. Defense Secretary Lloyd Austin's tour of Southeast Asia marked a step toward rebuilding alliances and regaining trust that had been declining in recent years. Secretary of Defense Lloyd Austin concluded his visit to the Philippines with a concrete strategic success: Manila announced it would officially restore the Visiting Forces Agreement (VFA) that makes it easier for American troops to operate on the archipelago.
